### 1. IDENTIFICATION:

### 2. INGREDIENTS AND EXPOSURE LIMITS:

#### 3. PHYSICAL DATA:

Melting Point: Decomposes at approximately 1,500° F and liberates carbon dioxide.

Appearance & Odor: White/gray in color; odorless solid. Specific gravity 2.65.

## 5. SPILL OR LEAK PROCEDURES:

<u>Spills:</u> Sweep or vacuum material from spill into a waste container for disposal.

<u>Waste Disposal Method:</u> This material can be disposed of in a landfill or by other procedures that are acceptable under Federal, State and Local regulations. Pickup and reuse clean materials. Limestone makes an excellent neutralizer for spilled acids. Material may be spread on lawns or fields to promote plant growth

#### 6. HEALTH HAZARD DATA:

No Major Exposure Hazard: Limestone is the non-technical or agricultural grade of calcium carbonate. The material is essentially non-toxic. The refined form of calcium carbonate is an excellent antacid and cosmetic ingredient. Calcium carbonate is a common air contaminant of insignificant concern. Extremely high concentrations of calcium carbonate dust are self-liming due to the nuisance conditions they may create causing coughing, sneezing and nasal irritation. Limestone dust may contain respirable silica particles. Silica is capable of causing silicosis if inhaled in high enough concentrations over an extended period of time.

<u>Emergency and First Air Procedures:</u> Emergency and first aid procedures typically do not apply to limestone. For dermal or eye irritation, flush with water. If irritation persists, refer to medical aid. Remove from exposure in cases of overwhelming dust generation.

## 7. REACTIVITY DATA:

Avoid contact with acid. Stable.

## 8. SPECIAL PROTECTION INFORMATION:

Respiratory: Appropriate NIOSH/MSHA approved dust respirators depending upon the type and magnitude of exposure.

Skin: Good personal hygiene. Clean work clothes and moisturizing creams.

Eyes: Safety glasses.

Ventilation: Mechanical ventilation to reduce dust concentrations.

Other Protective Equipment: None.
